MONTHLY PAYMENTS

GREENS FEES

You will pay \$5 for each 9-hole round at Lake Ridge Golf Course any day of the week at any time - no restrictions. Replay rounds will be charged at the same \$5 rate.

CANCELLATION

Written notice is required to cancel the membership and can be submitted at any time by emailing memberships@princewilliamgolfclub.com or memberships@lakeridgegolfclub.com. You must provide an email to join the membership, and the written cancellation must come from the email provided at joining. Upon receipt of written notice to cancel, there will be one final \$10 charge and 30-day period of benefits. Lake Ridge Golf Course may cancel this program at any time.

LIMITATION OF LIABILITY

Lake Ridge Golf Course will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Lake Ridge Golf Course has been advised of the possibility of such damages.
